There is a $\$ 550$ Security Deposit to secure your date at the signing of a contract and this does come off the total cost of the hall. This fee will be forfeited if the event is canceled or if the hall, kitchen, bathroom or parking lot is not returned back to the way it was upon arrival.

All events with alcohol or after 6 pm are subject for up to a $\$ 400$ (cash) charge for 1-2 police officers to be there for the last 4 hours of your event and due to our insurance we will provide the officers.

Caterers must have license, insurance, and workman's comp and meet with us first to use the stove, oven and dishwasher. Caterers have a $10 \%$ catering fee, based on the food only. If the Caterer is not on the list or you are doing your own food, you will still have access to everything in the kitchen except the stove, oven and dishwasher.

You must obtain hall rental insurance for that day through your home owner's/renters insurance with a coverage liability of $\$ 1$ million or you can get it through the Diocese @ \$150.
